# *Party in the Street* *Rules & Regulations*

*Line up begins on Magnolia between 9th & 12<sup>th</sup>*

*Check-in at 4:00 pm---Kick-off is 7:00 pm.*



***Complete entry form and return with entry fee of \$50.00  
no later than February 1, 2017***

The safety of parade participants and spectators is one of our primary concerns. Parade applicants are expected to obey the rules as determined by Leesburg Partnership, Inc.'s sole discretion.

- Horses must have walking handlers in costume and Pooper Scoopers! During Line-up and throughout the Parade!
- Please do not throw trinkets before you have entered onto Main Street, we do not want to encourage spectators into parade staging areas in search of beads.
- **No fireworks, pyrotechnics or silly string allowed on floats or Metallic Confetti.**
- Floats may be pushed or pulled by hand, golf carts, riding mowers, 4-wheelers or yard tractors, cars or trucks.
- We do require that all cars, trucks, tow units be licensed and covered by vehicle insurance and driven by a licensed driver. No boxed Semi trailers, flat beds only.
- **Carry in alcoholic beverages are NOT allowed in event area.**
- Recommended float specifications are:  
**Maximum hight-12 feet -- Maximum width-10 feet -- Maximum length-50 feet**
- Please remember that all entries have to be able to make a 90-degree turn.
- Understanding that a parade will have a multitude of spectators and that its primary purpose is to entertain, it is important that each participant keep this in the mind when deciding on its theme
- Entries are encouraged to throw beads, candies & plastic coins –the more the better!! Rule of thumb 1 Case (5 gross) of beads for each person throwing.
- All units waive the rights of reproduction for all advertisements and other promotions.
- Corporate sponsorship for units is acceptable as long as each unit does not exceed two 3 foot by 5 foot signs with corporate sponsor's names listed. You may have as many names on the sign as you wish, but all signage as well as unit must be in the "Spirit of Mardi Gras."
- **Absolutely No entry** will be allowed in the parade that is not decorated and lit in the "Spirit of Mardi Gras."
- We do not allow political candidates or publicity of such, social issues or targeted special interest groups. By making an application entry, please understand the parade committee has final decision authority.
- Please keep in mind this is a family event and govern dress & actions accordingly. No Profanity!

**Trophies will be awarded immediately after parade at the Judges' stand.**



**Hold Harmless and Indemnification**

This Agreement may not be modified or amended nor shall any provision of it be waived except by a writing signed by the parties, and in the case of the City of Leesburg, approved by the Leesburg City Commission at a public meeting.
